Find out about the Earned Income Tax Credit (EITC) – It's Money in Your Pocket

The Earned Income Tax Credit (EITC) is a **refundable** Federal tax credit for eligible taxpayers who work, but don't earn high incomes. To qualify, a taxpayer must meet certain rules and file a tax return, even if the taxpayer doesn't owe any tax or didn't earn enough money to require filing a return.

Who Qualifies

The adjusted gross income threshold amounts for 2009 tax returns follow:

- o \$13,440 (\$18,440 if married filing joint) if you do not have a qualifying child
- o \$35,463 (\$40,463 married filing jointly) if you have one qualifying child
- o \$40,295 (\$45,295 married filing jointly) if you have two qualifying children
- o \$43,279 (\$48,279 married filing jointly) if you have three or more qualifying children



To Complete Your Taxes You Must Bring in The Following Items:

- ✓ Proof of Identification
- ✓ Social Security Cards for you, your spouse and dependents and/or a Social Security Number verification letter issued by the Social Security Administration or ITIN.
- ✓ Birth dates for you, your spouse and dependents on the tax return
- ✓ Current year's tax package if you received one
- ✓ Wage and earning statement(s) Form W-2, W-2G, 1099-R, from all employers
- ✓ Interest and dividend statements from banks (Forms 1099)
- ✓ A copy of last year's Federal return *if available*
- ✓ Bank Routing Numbers and Account Numbers for Direct Deposit
- ✓ Total paid for day care provider and the day care provider's tax identifying number (the provider's Social Security Number or the provider's business Employer Identification Number)
- ✓ To file taxes electronically on a married filing joint tax return, both spouses must be present to sign the required forms.
